1. Product name

RETRON Finish Pigmented Series 619500

2. Description

Water based one-two component finish based on an acrylic copolymer with OH functional groups.

3. Main features

Water based one-two component finish based on an acrylic copolymer with OH functional groups, it can be cross linked by aliphatic isocyanate hardener code 730070.

Particularly suitable as a finish for the painting of furniture and related products, it can be easily roughened by sandpaper; excellent resistance to scratching and to products for the cleaning of the house. The product has good chemical resistance when used as one component, excellent chemical resistance when cured with the curing agent W MB code 730070.

The type of resins, along with the remaining components of the formulation, give the film excellent wetting of the substrate and speed of drying. To be applied, after roughening by sandpaper, on top of RETRON Primer W series 619000.

Store the product in cans not containing metals such as iron, copper, zinc, aluminum and their alloys.

4. <u>Recommended use</u>

Suitable for the coating of furniture, doors and entrance doors as described above.

6. Application data

Finish: various finish available, 30-20-5 gloss, angle 60° (ISO 2813). Color: RAL shades and others on request. Suggested DFT: $35 \div 45 \,\mu\text{m}$.

Theoretical consumption: $90 \div 120 \text{ g/m}^2 \text{ mixed product.}$

Practical spreading rate: roughly 30% lower than the theoretical by airless application ***.

7. Application method

Equipment: airmix spray or electrostatic airless by airbrush. Thinning: up to 5% potable water. Drying time:

- Touch dry approx. 1h at 20 °C and 50% RH
- Hard dry approx. 6-10 h at 20 °C and 50% RH
- Fully cured approx. 24 h at 20 °C and 50% RH
- The drying times vary with the thickness, the thinning ratio and the weather conditions.

The product achieves the max hardness after 4 weeks.

Number of coats: 1 or 2 coats as described above.

Application conditions: application suggested between 15 °C and 30 °C, RH<50% and good ventilation.

Pot life: approx. 3 h at 23 ℃; do not use the product after 3 h from the mixing.

Mixing ratio: 100:10 by weight with curing agent "W" "MB" code 730070

Overcoating time: RETRON Finish can be overcoated by itself without sandapering after 3-4 h or after 24 h by suitable sandpapering.

With addition of 0.5% by weight of the IG Silver Barrier cod. 907050 Product catalyzed with 10% hardener cod. 730070, you get an effective barrier to the proliferation of molds and bacteria.

10. Storage indications

Shelf life: 12 months, provided the cans are kept sealed and undamaged, into a cool and dry place with temperature between 5 and 35°C.

Susceptible to frost damage.
